ORDINANCE NUMBER 1992-1

AN ORDINANCE AMENDING ORDINANCE NUMBER 1982-3, AS AMENDED, AN ORDINANCE ESTABLISHING A COMPREHENSIVE SYSTEM FOR THE COLLECTION, REMOVAL AND DISPOSAL OF ALL GARBAGE WITHIN THE BOROUGH OF WEST NEWTON AND PROVIDING FOR THE REPEAL OF ALL ORDINANCES OR PARTS OF ORDINANCES INCONSISTENT HEREWITH IN ORDER TO RAISE THE RATES TO BE CHARGED FOR THE COLLECTION OF GARBAGE.

BE IT ORDAINED AND ENACTED by the Town Council of the Borough of West Newton, Westmoreland County, Pennsylvania, and it is hereby ordained and enacted by the authority of the same as follows:

SECTION 1: Section 5 c. (1) of Ordinance 1982-3, as amended, is hereby amended to read:

Section 5 Collection Practices

- c. Rates and charges for collection.
- (1) Each private family residential customer shall pay the Borough or its authorized collector the sum of TWENTY ONE and 70/100 (21.70) Dollars quarterly in advance or EIGHTY TWO and 58/100 (82.58) Dollars annually in advance (by January 31). This rate shall be based on a maximum of four (4) containers not weighing more than forty (40) pounds, when filled. Any person requiring additional collections or collections in excess of the quantity hereinabove set forth shall negotiate a fair and equitable rate for such additional collections or additional quantities, or both, directly with the Collector. The above quarterly and annual rates are subject to being increased if the Collector obtains increases in rates under the procedures set forth in his contract with West Newton Borough. Those who have paid annually in advance will be billed on a pro-rata basis for the increases over the remaining months of the year for which the increases apply. Those who have paid quarterly in advance will be billed on a pro-rata basis for the increases over the remaining months of the quarter for which the increases apply.

SECTION 2: SECTION 5 c. (3) of Ordinance No. 1982-3, as amended, is hereby amended to read:

Section 5 Collection Practices

- c. Rate and charges for collection.
- (3) Each senior citizen who is sixty-five (65) years of age or older and who is the head of a household that contains no other wage earner shall pay the Borough or its authorized collector the sum of TWENTY

and 20/100 (20.20) Dollars quarterly in advance or SEVENTY SIX and 52/100 (76.52) Dollars annually in advance (by January 31). This rate shall be based on a maximum of four (4) containers not

weighing more than forty (40) pounds, when filled. Any person requiring additional collections or collections in excess of the quantity hereinabove set forth shall negotiate a fair and equitable rate for such additional collections or additional quantities, or both, directly with the Collector. The above quarterly and annual rates are subject to being increased if the Collector obtains increases in rates under the procedures set forth in his contract with West Newton Borough. Those who have paid annually in advance will be billed on a pro-rata basis for the increases over the remaining months of the year for which the increases apply. Those who have paid quarterly in advance will be billed on a pro-rata basis for the increases over the remaining months of the quarter for which the increases apply.

SECTION 3: Any ordinance or part of an ordinance in conflict with the terms of this Ordinance is, and the same are, hereby repealed.

SECTION 4: This Ordinance shall become effective on March 9, 1992.
